Upon the motion of Kymberly Gillespie, seconded by Forrest Roles, the SPB voted and approved, as modified, the proposal to implement a non-base building pay differential for all classified employees of the Lewis County Health Department.

#### **3158 Harrison-Clarksburg Health Department**

Upon the motion of Jim Dissen, seconded by Rick Wallace, the SPB voted and approved the proposal to implement a 3% across-the-board base building salary adjustment for all classified employees of the Harrison-Clarksburg Health Department.

#### **3159 Wheeling-Ohio County Health Department**

**3169 Tucker County Health Department**


